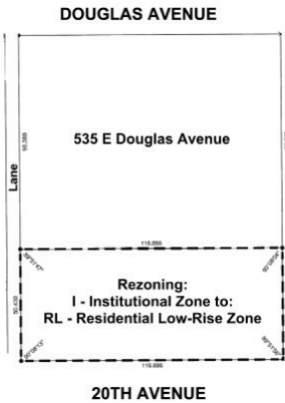

PUBLIC NOTICE: ZONING BYLAW AMENDMENT

Regina City Council will consider an amendment to *The Regina Zoning Bylaw, 2019* – the properties identified, and as shown on the map below, will be considered for rezoning as follows:

Legal Description:	Lot 15-Blk 2-Plan GD1553 Ext 0
Civic Address:	535 E Douglas Avenue
Neighbourhood:	Boothill
Current Zoning:	I – Institutional Zone
Proposed Zoning:	RL – Residential Low-Rise Zone



REASON: The Proponent is applying for the above noted amendment (rezoning) in order to pursue a 90-unit residential building, plus day care operation, at the Subject Property. The current I – Institutional Zone does not allow for a residential development of this type.
