## City of Regina - Winter City Stamp Rally Game 2025 Official Rules and Regulations

### 1. Overview

**Contest/Game Name (“Game”):** Winter City Stamp Rally Game 2025

**Description:** An interactive, location-based game where participants visit designated, real-world locations, collect digital stamps, earn points and unlock prizes.

**Contest Type:** Stamp Rally and Random Draw

**Game Period:** 12:00 a.m. on December 12, 2025 to 4:00 p.m. on March 15, 2026, CST.

**Platform Disclaimer:** This Game/Contest is not sponsored, endorsed, or administered by PlayTours PTE.LTD, Microsoft, or any other third-party app or platform used by the Sponsor to operate, administer or promote this Game/Contest.

**Official Rules and Regulations (the “Rules”, “Game Rules”, “Contest Rules”):** By participating in the Game, the Participant agrees to accept and abide by these Rules. All decisions of the Sponsor with respect to any aspect of the Game, including without limitation the eligibility of Entries, are final and binding on all Participants in all matters as they related to this Game.

### 2. Eligibility

Participation is only open to residents of any Canadian province or territory except Quebec who have reached the age of majority in their province or territory of residence by the end of the Game Period. Participants under the age of 18 (“Eligible Minor”), may play the game, but prizes must be claimed by their parent or legal guardian.

The Sponsor reserves the right to verify the validity and originality of any Participant/Entry (including a Participant’s identity and/or address) and to disqualify any Participant who submits an entry or claims a prize that is not in accordance with these Rules. Failure by the Sponsor to enforce any of its rights at any stage does not constitute a waiver of those rights.

### 3. How to Play & Enter

There are two ways to play.

**Option 1:** Using the official Game Platform with a mobile device (“**Online**”)

- Participants will play the Winter City Stamp Rally Game using the official game platform found at [Regina.ca/StampRally](http://Regina.ca/StampRally). Participants will collect digital stamps at designated locations using their mobile device. Stamps are collected by using the mobile device’s internet and GPS location data to verify their presence at a designated location and claiming the Stamp. Collecting stamps earns points for the Participant.
- Internet access, GPS and a compatible device are required to play using the Online method.

**Option 2:** Using the Alternative Method of Play with the Game Sheet (“**Offline**”)

- Participants will play the Winter City Stamp Rally Game using a downloadable Game Sheet found at [Regina.ca/StampRally](http://Regina.ca/StampRally). Participants will print the Game Sheet and use it to keep track of their progress. Participants will visit designated locations and write a short statement about their experience on the Game Sheet. Completing a location earns points for the Participant.

Primary Prize eligibility is unlocked for the first 200 Participants who earn **100** points and complete the Prize Claim Task at City Hall. A Grand Prize entry ballot eligibility is unlocked for each Participant when they earn **150, 300, 450, 600** and **750** points.

No purchase necessary.

Odds of winning depend on the number of eligible entries received and number of players.

## 5. Winner Selection and Notification

### Primary Prize Selection:

Awarded to the first 200 participants who reach the **100**-point threshold and complete the Prize Claim Task at City Hall. After all available Primary Prizes are distributed, no further Primary Prizes will be awarded.

### Primary Prize Notification:

**Online:** Participants will see a "Prize Claim Task" appear in the Game once they reach **100** points. Participants are responsible for completing this task to claim their prize. Failure to complete this task will result in forfeiting the prize and selection of an alternate winner.

**Offline:** Participants are responsible for keeping track of their points. Once they reach **100** points, Participants must submit their completed sheet (by email or by visiting City Hall) to have it verified. Once verified, the Participant must visit City Hall during business hours to claim their prize. Failure to complete this task will result in forfeiting the prize and selection of an alternate winner.

**Grand Prize Selection:**

Participants will receive an entry ballot for the Grand Prize Draw for **every 150 points** they earn in the game. Participants must submit their entry ballot(s) by the end of the Game Period to be considered for the random draw. All eligible entries will be included in the random draw which will occur on or after March 23, 2026.

**Grand Prize Notification:**

The selected Potential Winner will be notified by email or phone (this information will be requested on the entry ballot) and must respond within 5 business days.

**Skill-Testing Question:**

Primary Prize and Grand Prize winners must correctly answer a mathematical skill-testing question before receiving the prize.

**Prize Claim and Release Forms:**

Winners of the Primary Prize and Grand Prize may be required to sign and return forms before receiving the prize, including:

- (a) A form affirming eligibility and compliance with all Game Rules;
- (b) A liability release form releasing the Sponsor, their directors, employees, officers, agents and affiliates from all liability arising from or relating to the acceptance, receipt, possession, use or misuse of an awarded Prize, participation in any Game-related activity and/or participation in the Game; and

Winners of the Primary Prize and Grand Prize may have their name and/or photo posted on the City of Regina's official social media channels as part of the promotion of the Game.

**Reallocation of Prize:**

If any selected entrant is not eligible, does not otherwise meet the requirements as set out in the Contest Rules, fails to submit the required documents or information to the Contest Sponsor as required by the Rules, or fails to claim the prize as required by the Rules, the Contest Sponsor will have the right to disqualify said entrant and randomly draw another eligible entry for purposes of awarding a Prize. The Contest Sponsor will be fully and completely released and discharged from any liability or responsibility in this regard.

**Technical Disclaimer:**

The City of Regina is not responsible for lost, late, misdirected, incomplete, or incompatible entries.

## 6. Participating / Designated Locations (Game Play Locations)

Participants must visit any of the following Designated Locations during the Game Period to collect Stamps (using either the Online or Offline method of play). For Designated Locations labelled as “**Special Events**”, Participants may only collect stamps and earn points during the Special Event Period associated with that Location. For example, a participant may only collect the stamp and earn points when they are present at a “FROST Regina” event during the dates and times that the Special Event is taking place. If the Participant is present at the location but outside the Special Event Period, they cannot receipt the Stamp/Points associated with that Special Event.

**List of Designated Locations, Addresses, Categories, and Points:** See “**Appendix A**”.

The Sponsor reserves the right to add, modify or remove any Designated Location in the Game at any time before, during or after the Game Period for any reason and without notice to Participants.

## 7. Privacy and Data Use

Personal information collected will be used solely for contest administration and handled in accordance with The Local Authority Freedom of Information and Protection of Privacy Act (LAFOIP). For questions, contact [lafoip@regina.ca](mailto:lafoip@regina.ca).

Your name, email address, phone number and other personal information are not required to play the game. Your name, email address and/or phone number may be required to enter the Grand Prize draw, to administer the Grand Prize draw and as part of the promotion of the Game.

Game data, including data stored and collected on the game platform, will be destroyed after the Game Period.

The Sponsor will not sell or transmit this information to third parties except for the purposes of administering this Game/Contest. Any inquiry concerning personal information held by the Sponsor should be addressed to City of Regina at 306-777-7000.

This Contest is governed by the laws of Saskatchewan and the laws of Canada applicable therein, and is subject to all applicable federal, provincial and municipal laws and regulations.

By entering this Contest, the Participant agrees that the courts of the Province of Saskatchewan, Canada shall have jurisdiction to entertain any action or other legal proceedings based on any provision of the Game Rules or the running of the Game. The entrant hereby irrevocably attorns to the exclusive jurisdiction of the courts of the Province of Saskatchewan.

The Sponsor reserves the right, in their sole discretion, to terminate, modify or suspend the Game, or modify the Game Rules at any time for any reason whatsoever.

Submissions must not, in the sole and unfettered discretion of the Contest Sponsor, contain obscene, provocative, defamatory, sexually explicit, or otherwise objectionable or inappropriate content. Any Submission that is considered by the Contest Sponsor in its sole and absolute discretion to be obscene, pornographic, libelous, hate speech or otherwise objectionable, in whole or in part, may be disqualified.

The Sponsor will not be liable for any human or technical errors that may arise or occur in connection with the Game, including, but not limited to use of the game or submission of any prize claim.
