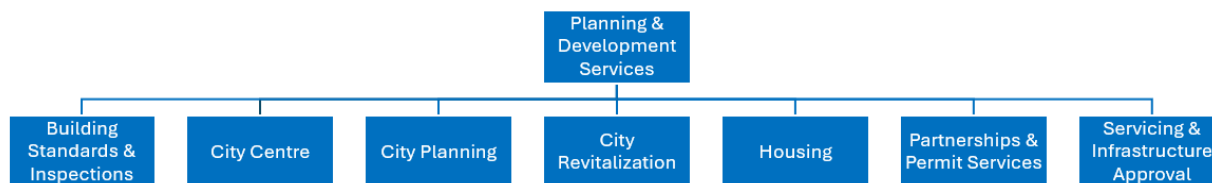
Payments for permit applications are accepted online.
