Proposal	<p>The Applicant proposes to develop a 3,023m² building, to be used as an “Institution, Humanitarian Service” land-use (e.g. social services), at the following location: 2735 5TH Avenue; 1111, 1113, 1121 Rae Street (Subject Property).</p> <p>This Proposed Development will require:</p> <ul style="list-style-type: none"> • That a portion of the Subject Property (1111, 1113, 1121 Rae Street) be rezoned from RU – Residential Urban Zone to ML – Mixed Low-Rise Zone. • Review through the Discretionary Use procedure, as the “Institution, Humanitarian Service” land-use exceeds 300 square metres. <p>To understand land-use and development types potentially allowable in the ML Zone, please review Part 4A, Table 4A.T2 of Chapter 4 of the City’s Zoning Bylaw:</p> <p>https://open.regina.ca/dataset/bylaw-no-2019-19-the-regina-zoning-bylaw-2019/resource/e29a237b-ad80-4cba-89f3-3fe990d04e89</p>
Additional Information	<p>The Subject Property is comprised of:</p> <ul style="list-style-type: none"> • An existing lot and building, which is owned by the Applicant; used as residential units and “Institution, Humanitarian Service” land-use; zoned ML Zone. • Three residential lots; two single-detached residential buildings; zoned RU Zone. <p>These buildings will be demolished to accommodate the proposed new building.</p>
Process	
Review / Decision	<p>Following the public and technical review process, which is currently underway, the Administration will submit a report to the decision authority, which will include a summary of the public comments, as well as Administration’s recommendation.</p> <p>The decision authority respecting Zoning Bylaw and Official Community Plan amendments, and where a Discretionary Use application also applies, is the Regina City Council. Applications directed to Council will be considered, first, by the Regina Planning Commission (RPC) who will then provide a recommendation to Council.</p> <p>Both the RPC and Council meetings are open to the public; therefore, you may attend these meetings and view the deliberation, or speak directly to the RPC or Council. Please refer to the Application Review Process on back of page.</p> <p>If you wish to be kept informed about the date and time of these meetings, be sure to give the City your contact information.</p>

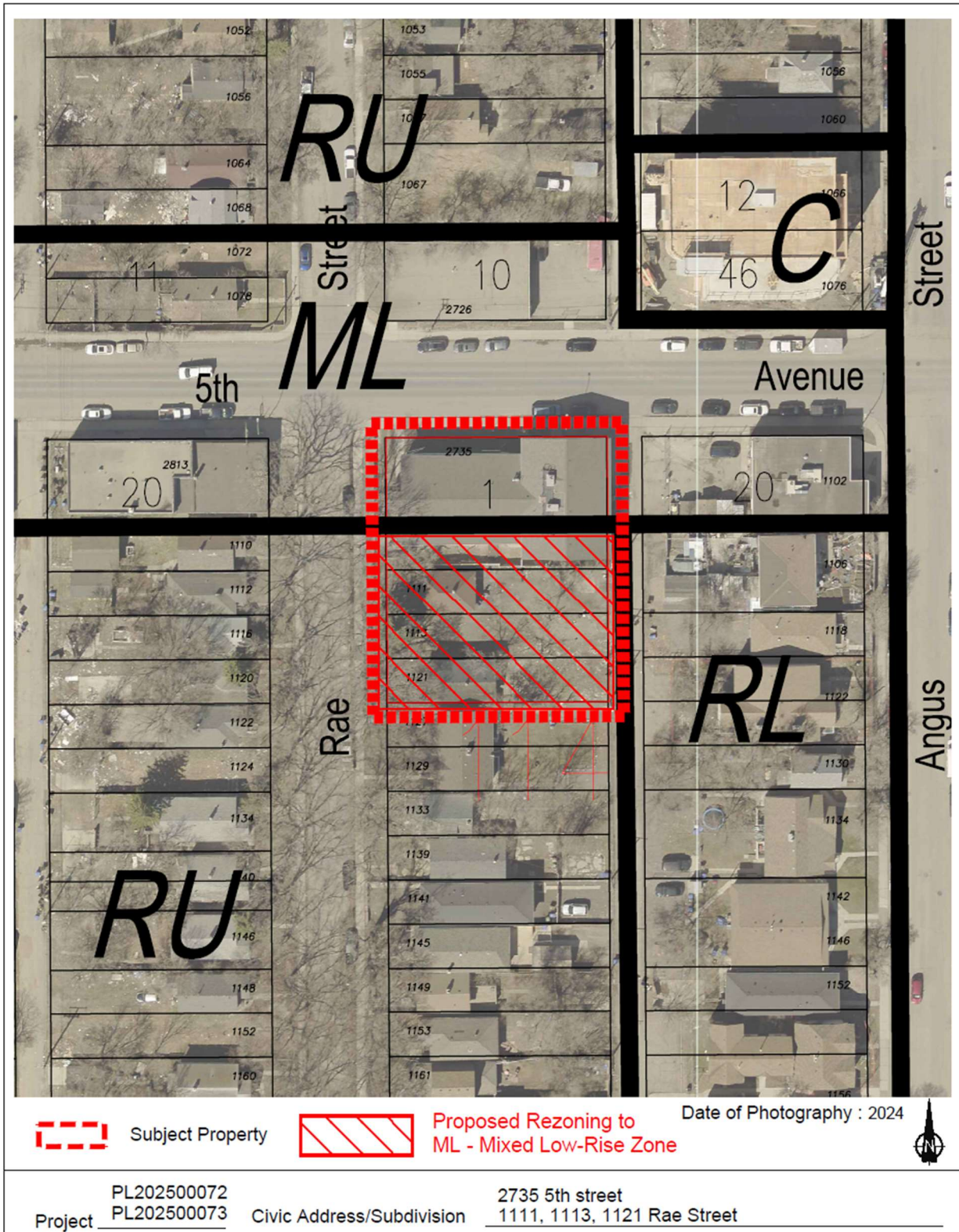

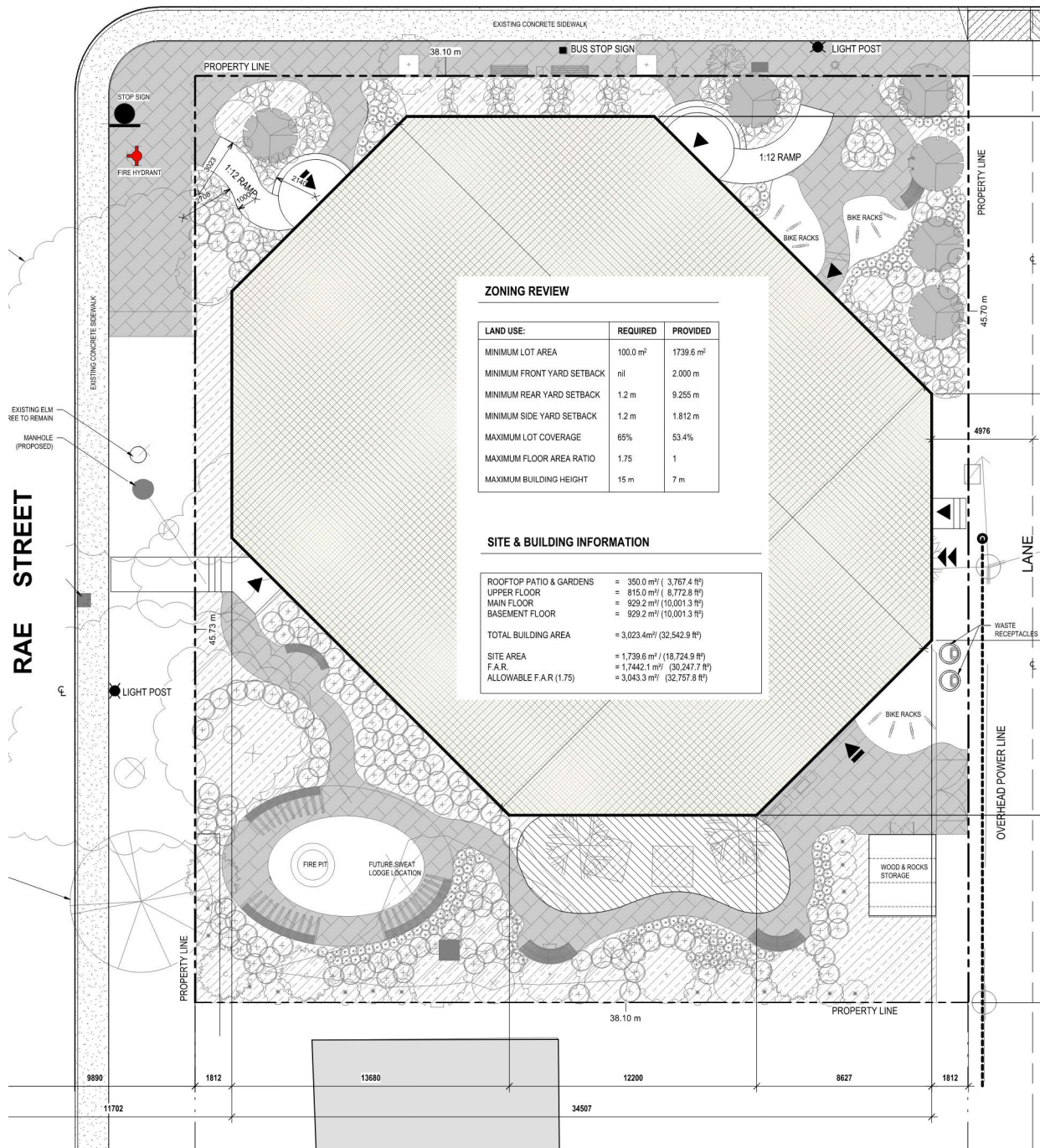

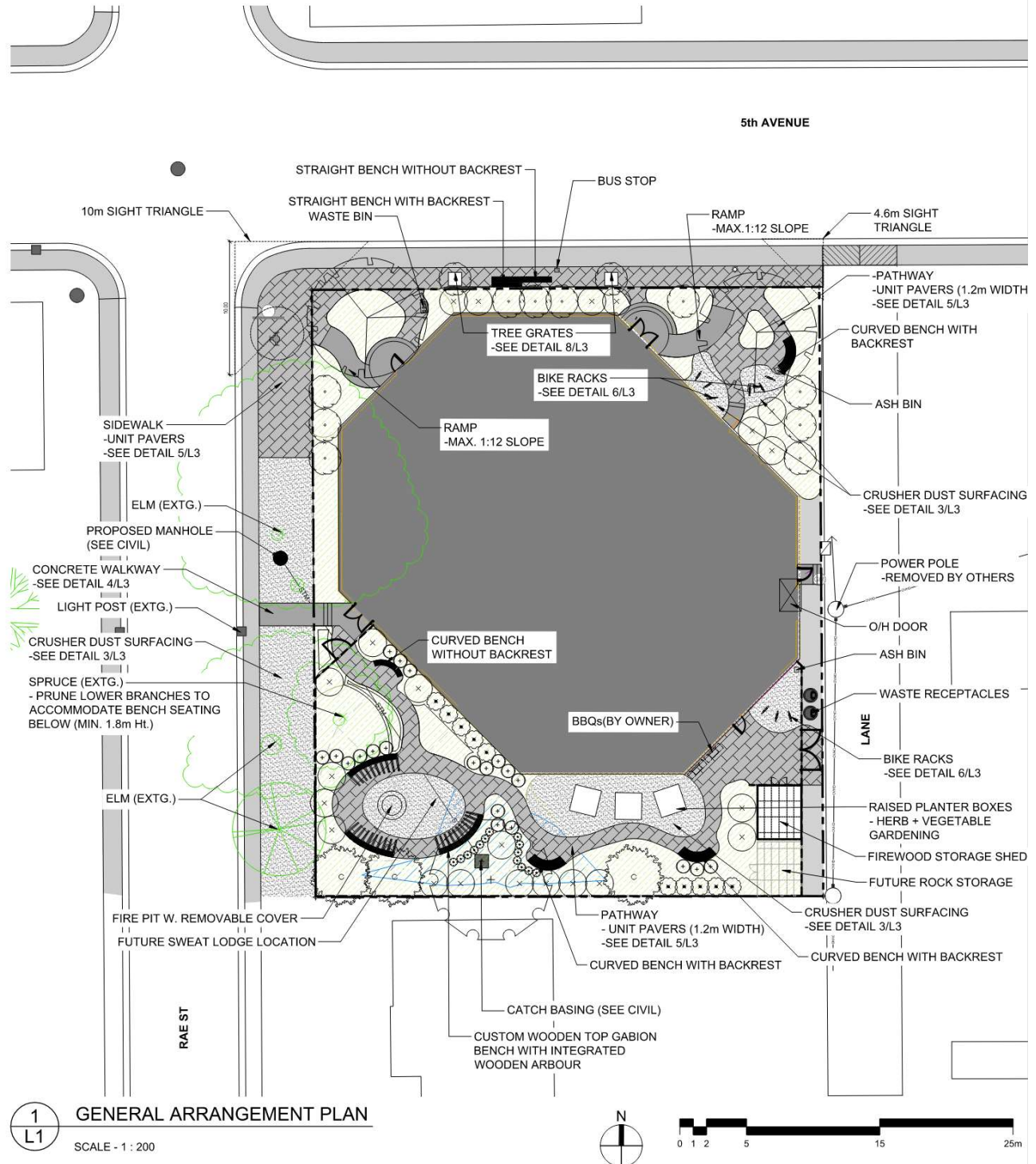

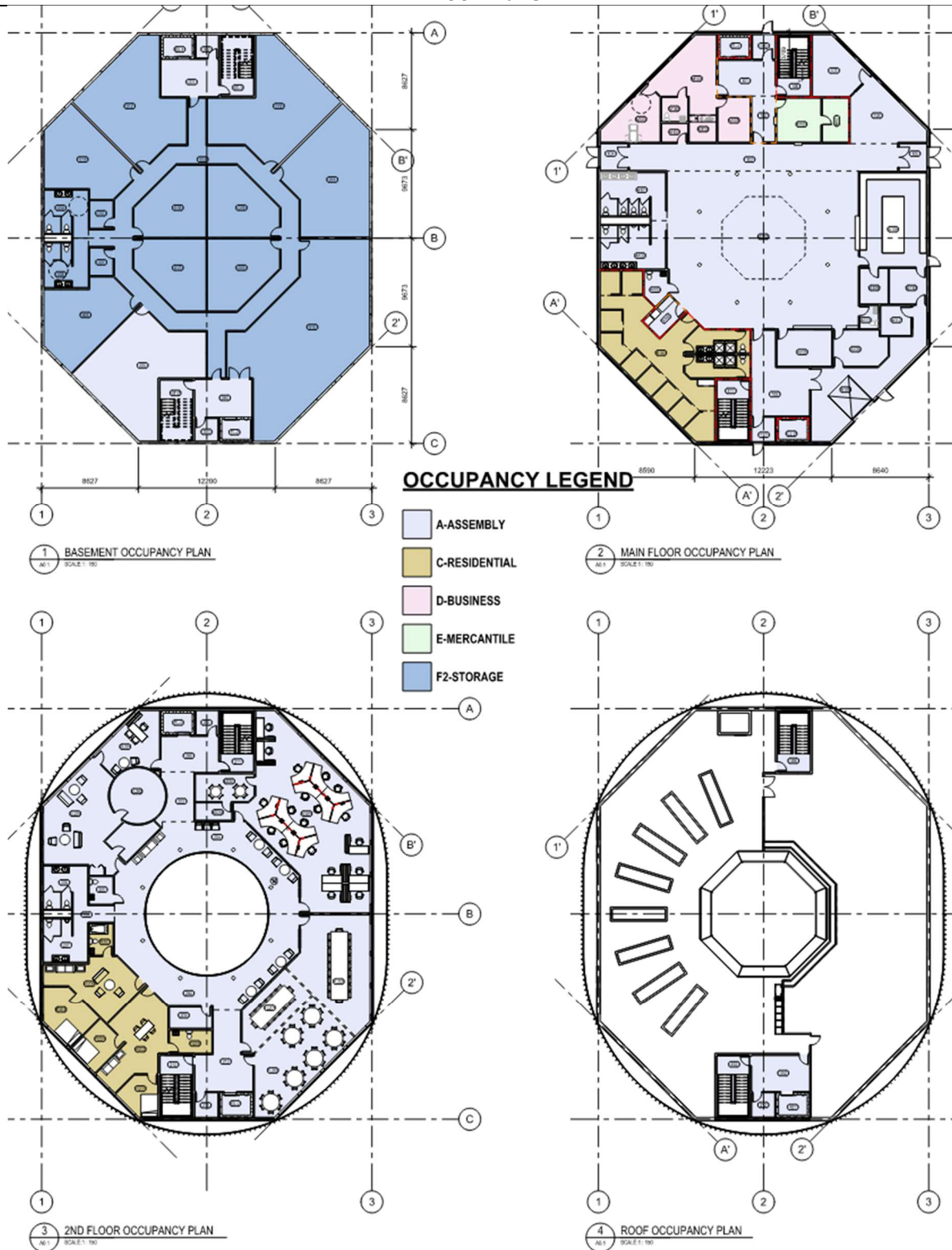
Appendix C1 – Proposed Development Site Plan

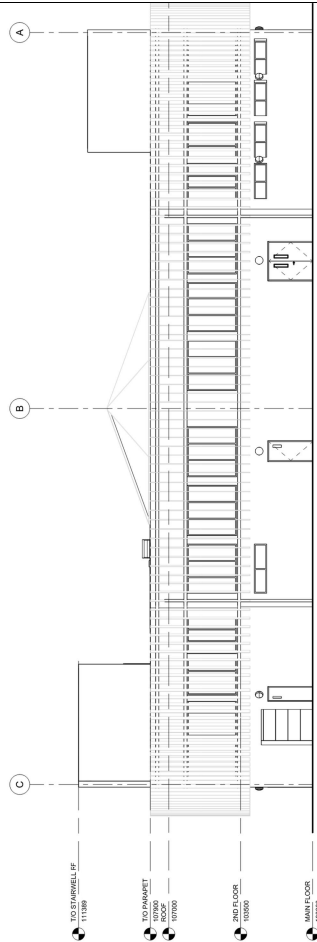

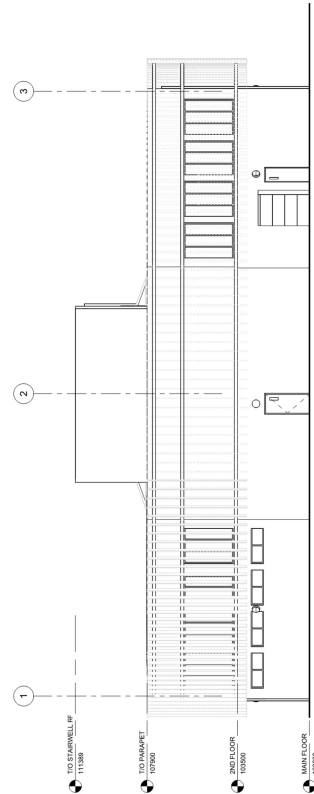

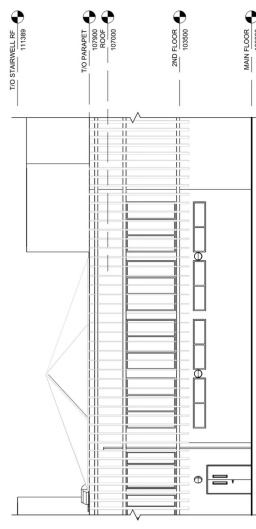

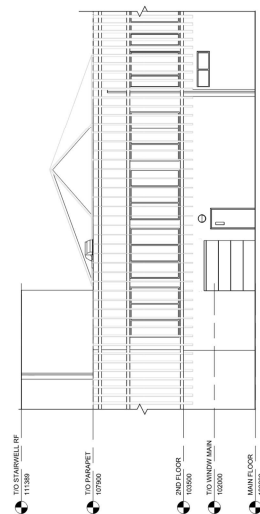

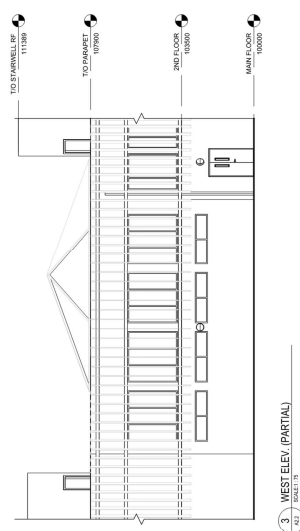
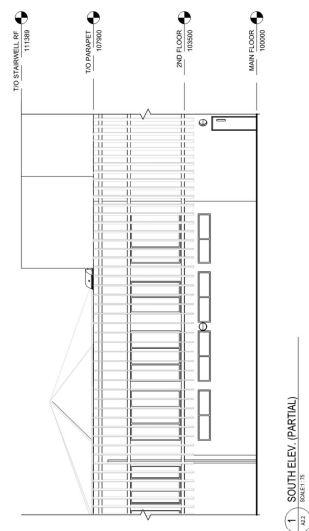
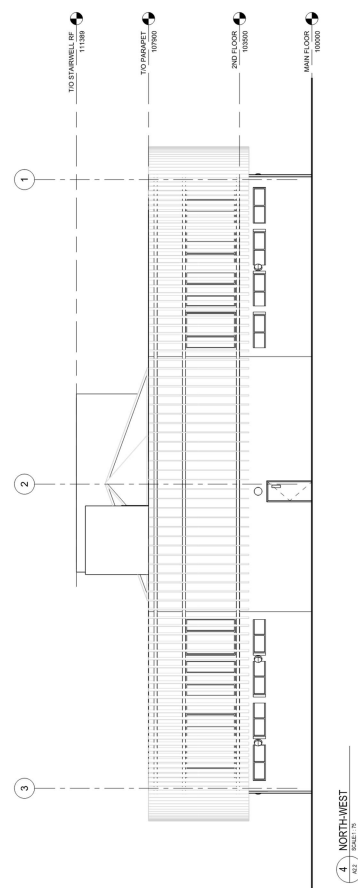
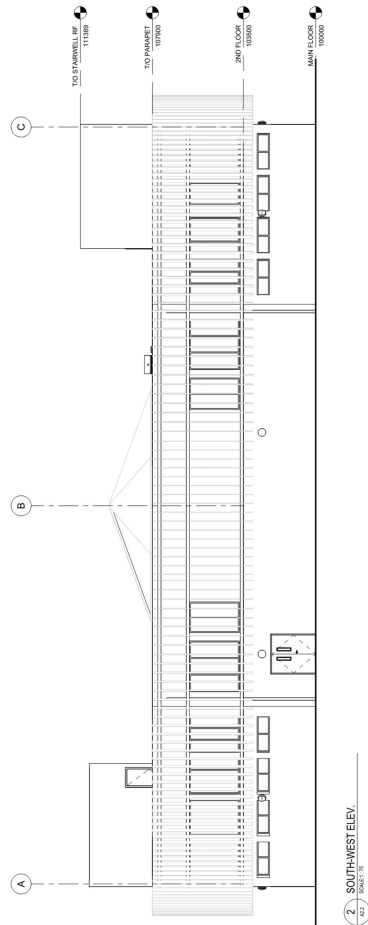


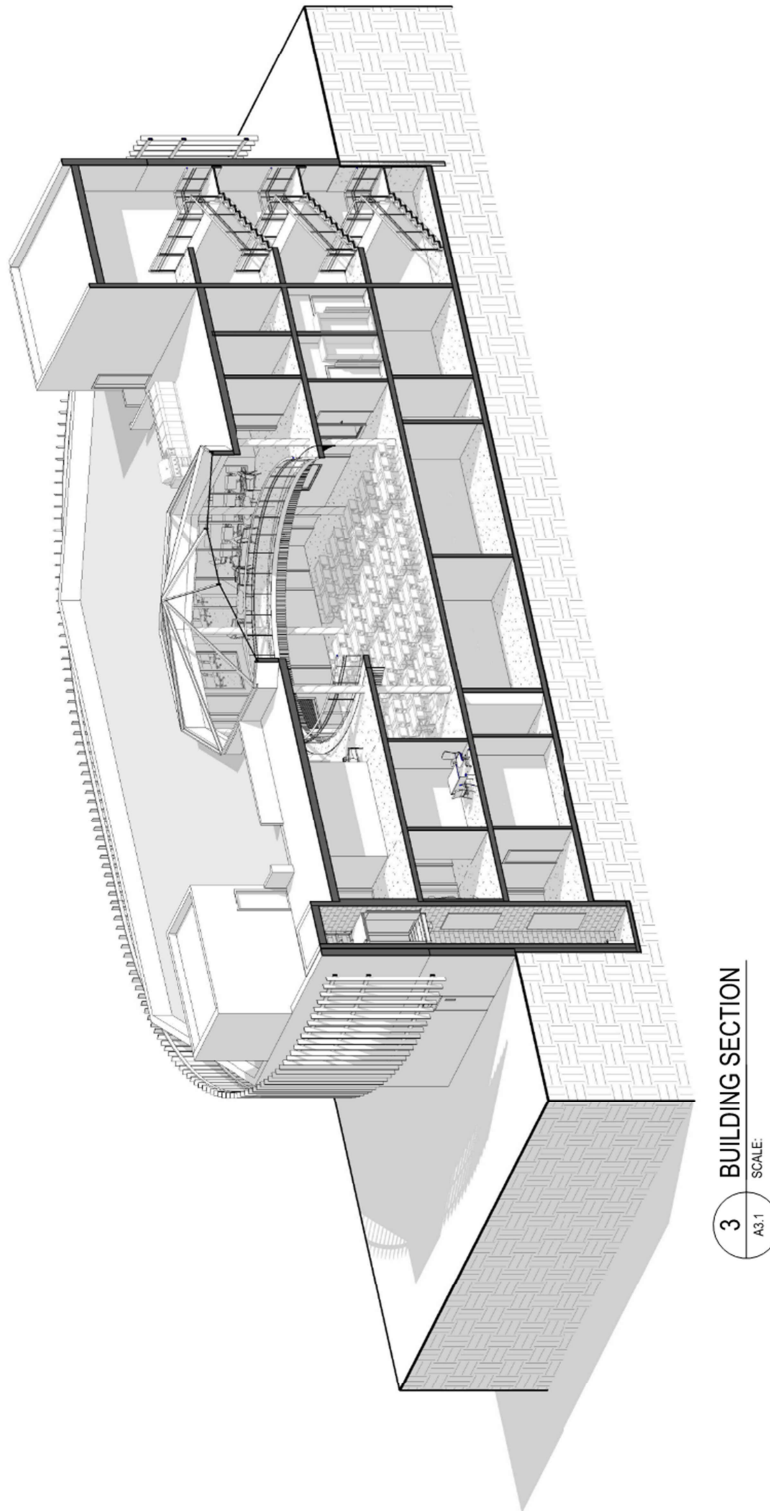
1 NORTH ELEV. (PARTIAL)
