TO CONSIDER AMENDMENTS TO
THE INVESTMENT POLICY

The City of Regina hereby gives notice, pursuant to sections 101 and 102 of *The Cities Act* and *The Public Notice Policy Bylaw, Bylaw No. 2020-28*, of its intention to consider a report and amendments to the City’s Investment Policy that are contained within Bylaw 2003-69 being *The Regina Administration Bylaw*. The amendments are required to update the mid-term and long-term investment asset mix limits.

The particulars of the reports and Bylaw amendments will be considered by the City’s Audit and Finance Committee on October 30, 2025 at 4:00 pm and City Council on November 5, 2025 and November 19, 2025 and may also be considered at subsequent meetings. Both City Council meetings listed are at 1:00 pm. Citizens who want to address the Audit and Finance Committee on October 30, 2025 may attend via teleconference or in person. To attend, you must register by completing the online form on [Regina.ca/register](#) no later than noon on October 27, 2025.

Citizens who want to address City Council on November 5, 2025 or November 19, 2025 may attend the meetings via teleconference or in person. To attend Council, you must register by completing the online form on [Regina.ca/register](#) to request to address City Council on these matters. The deadline to register is no later than noon on November 3, 2025 for the November 5, 2025 meeting and noon on November 17, 2025 for the November 19, 2025 meeting. BYLAW AMENDMENTS

Notice of Intention to Consider Changes to *The Regina Administration Bylaw*, and *The Public Notice Policy Bylaw*.

The City of Regina (City) hereby gives notice, pursuant to sections 101 and 102 of *The Cities Act* and *The Public Notice Policy Bylaw, Bylaw No. 2020-28*, of its intention to consider a report and bylaw amendments to *The Regina Administration Bylaw No. 2003-69*, including Schedule D – The Purchasing Policy and Bylaw No. 2020-28, *The Public Notice Policy Bylaw, 2020*.

The recommended changes to *Regina Administration Bylaw No. 2003-69* updates the language, processes and applicable dollar amounts to align with best practices in procurement practices and the applicable trade treaties and provide enhanced clarity for the City’s administration.

The Regina Administration Bylaw No. 2003-69 sets out the City’s framework for procuring goods, equipment, and services, including the authorities and conditions under which procurements can be authorized. It aims to balance the City’s operational needs with its responsibility to remain accountable to both residents and vendors. The proposed amendments align with trade agreements, legislated requirements and best practices while clarifying the process through standardized language. They ensure the City’s procurement processes are conducted in an effective, open, fair, transparent, accountable and efficient manner while enabling new ways for the City to procure goods, services, construction and consulting services.

The recommended changes to *Bylaw No. 2020-28, The Public Notice Policy Bylaw, 2020*, remove newspaper advertising as a required method of providing minimum public notice for the establishment of and amendments to the City’s *Investment Policy*; borrowing, lending or guaranteeing the repayment of a loan; moving capital moneys to the City’s operating budget or operating reserve; and establishment of and amendments to the City’s *Purchasing Policy* as identified in clauses 101(1)(e), (F), (i) and (j) of *The Cities Act*. The other methods of providing public notice on the City’s website and on the public noticeboard at City Hall would continue. The changes recommended do not affect other *Cities Act* or *Planning and Development Act, 2007* matters that require public notice. Those will continue to be published in the newspaper.

Particulars of the report and amending Bylaws will be considered at the **Audit and Finance Committee meeting on Thursday October 30, 2025 at 4:00 p.m.**, and by **City Council at its meeting on Wednesday, November 19, 2025 at 1:00 p.m and by City Council at its meeting on Wednesday, December 3, 2025**. All meetings are in Henry Baker Hall, City Hall and citizens may attend via teleconference or in person. The report and bylaw may also be considered at subsequent meetings of City Council.

- Facilitate a public hearing(s) respecting proposed amendments to *The Regina Zoning Bylaw, 2019* (application to rezone property), as described below.

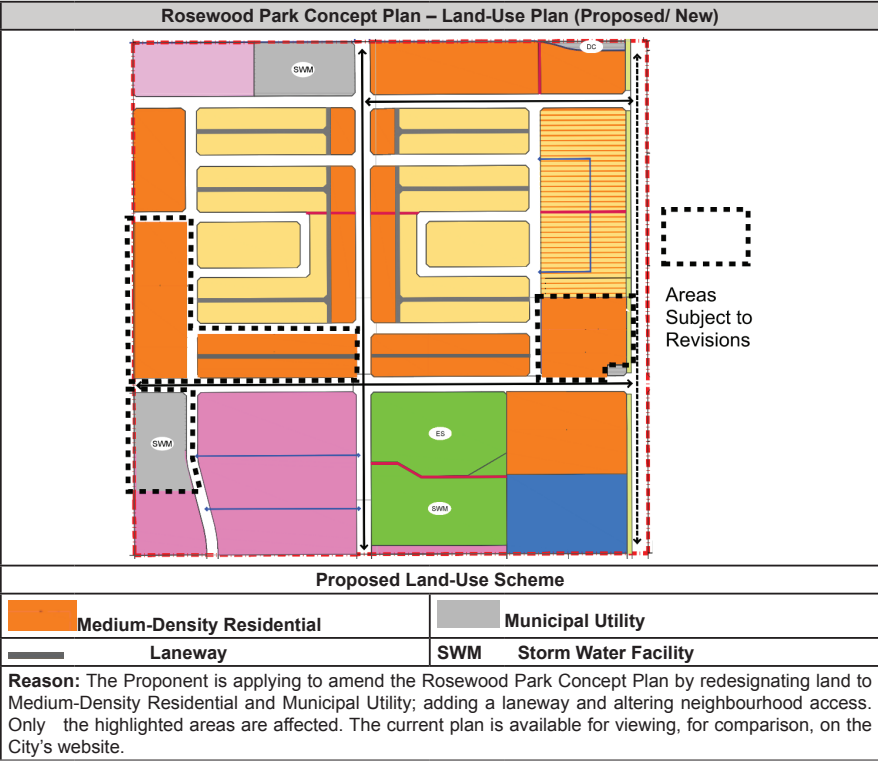
Citizens who want to address City Council may attend the meeting in person or via teleconference.
