

# DEVELOPMENT LEVY BYLAW AMENDMENT PROPOSED AMENDMENT

Regina City Council intends to consider an amendment to *The Development Levy Bylaw, 2011* which will affect land and development within the benefitting area depicted in the map below.



**REASON** – The proposed amendment will update Schedule A – Development Charges Policy of *The Development Levy Bylaw, 2011* to reflect policy changes identified in the *Municipal Front-ending Wastewater Lift Stations* report approved by City Council on June 25, 2025. Specifically, these changes will establish a municipal front-ending policy for the Northwest Regional Wastewater Lift Station, including area-specific development charge rates to be imposed upon development of lands within the area for the purpose of recovering a portion of the project cost.

## **NOTICE OF INTENTION**

# TO CONSIDER LONG-TERM DEBT FINANCING FOR THE INDOOR AQUATIC FACILITY

The City of Regina hereby gives notice, pursuant to sections 101 and 102 of *The Cities Act* and *The Public Notice Policy Bylaw*, *Bylaw* No. 2020–28, of its intention to consider incurring long-term debt financing for the new indoor aquatic facility (IAF) under the upcoming "Indoor Aquatics Facility – Design and Cost Options" report. The City will consider incurring debt in the maximum principal sum of \$186 million, consisting of \$146 million previously approved by City Council plus a maximum additional amount of \$40 million to cover current project budget increases. This is in addition to \$13.8 million in debt financing previously approved for the geothermal heating facility attached to the IAF.

The IAF was identified as the top priority in the City's Recreation Master Plan. This facility will provide an important recreation and community facility that will be attractive to residents and lead to a better overall community. The IAF will provide a welcoming and inclusive facility for everyone that provides both leisure aquatics as well as competition aquatics. It will be located on the existing Sportplex site and following the opening of the IAF, the Lawson Aquatics Centre will be decommissioned. The upcoming report proposes that the City re-prioritize capital projects to limit the amount of debt required to move the IAF project forward. Council has approved a dedicated mill rate of 0.5 for 5 years as part of the 2025 budget process to re-pay the IAF debt principal and interest costs.

The particulars of the report will be considered by the **Executive Committee on July 23, 2025**, at 9:00 am and City Council on July 30, 2025, at 1:00 pm and may also be considered at subsequent meetings. Both the Executive Committee and City Council meetings are held in Henry Baker Hall, City Hall and citizens may attend via teleconference or in person.

Citizens who want to address the Executive Committee on July 23, 2025, must register by completing the online form on Regina.ca/register no later than noon on July 21, 2025. Citizens who want to address City Council on July 30, 2025, must register by completing the online form on Regina.ca/register to request to address City Council on these matters. The deadline to register is no later than noon on July 28, 2025. A written brief is required to present at a Council meeting. 


### OFFICIAL COMMUNITY PLAN AMENDMENT

### PROPOSED AMENDMENT

Regina City Council intends to consider amendments to Bylaw 2013-48, being *Design Regina: The Official Community Plan* (OCP) by amending Part A, Section F – Maps, Map 1: Growth Plan and Map 1b: Phasing of New Neighbourhoods as depicted below. The amendments will re-designate the proposed Westbrook Neighbourhood from a "Special Study Area" to a "New Neighbourhood (300k)" in Map 1 and from a "Special Study Area" to a "Phase 1 Neighbourhood" in Map 1b.

**REASON** – The maps are being updated to implement recommendations approved by City Council on June 25, 2025 in the *Municipal Front-ending Wastewater Lift Stations* report. Under this report, City Council approved the construction of the Northwest Regional Wastewater Lift Station that will service the proposed Westbrook Neighbourhood. Since the lift station provides a servicing solution to the proposed neighbourhood, a "Special Study Area" designation for these lands is no longer required.
