



PROPOSED TEXT AMENDMENTS

- 1. Amend Chapter 2, Part 2B by replacing the definition for "front lot line".
- Amend Part 4A (ML Mixed Low-Rise Zone) and 4B (MH Mixed High-Rise Zone) 2. of Chapter 4: Allow Minimum Front Yard Setback to be reduced to nil where the development includes other streetscape enhancing features, in lieu of an Active Wall.


These revisions are intended to provide greater flexibility and opportunities in relation to front yard setback areas.
