PUBLIC NOTICE ZONING BYLAW AMENDMENT

Regina City Council intends to consider the following amendments to *Regina Zoning Bylaw*, 2019 (Zoning Bylaw):

- Require that, for Dwelling, Unit Building, Stacked, outside of the Intensification Area boundary, as shown on Map 1c of *Design Regina: The* Official Community Plan Bylaw 2013-48, the minimum parking requirement, for motor vehicles, shall be 1.5 stalls per dwelling unit, in accordance with the following additional stipulations:
 - a. Apply these amendments to the following zones:
 - i. Residential Low-Rise Zone
 - ii. Residential High-Rise Zone
 - iii. Mixed Low-Rise Zone
 - iv. Mixed High-Rise Zone
 - v. Mixed Large Market Zone
 - b. Allow for the following exceptions:
 - i. Where the dwelling unit has a total floor area of 60m² or less, the minimum parking requirement shall be 1 stall per dwelling unit;
 - ii. Where a lot is within an Urban Centre or Urban Corridor, as shown on Figure 1.F1 of the Zoning Bylaw, the minimum parking requirement shall be 1 stall per dwelling unit.
- 2. Amend Figure 1.F1 of the Zoning Bylaw by adding, as additional information, the Intensification Area Boundary, as shown on Map 1c of *Design Regina: The Official Community Plan Bylaw 2013-48*.

REASON – The intent of these amendments is to require that multi-unit residential buildings, in a "suburban" context (outside of the City's Intensification Area), provide additional on-site motor vehicle parking. Currently, the minimum parking requirement is 1 stall per dwelling unit; therefore, 1.5 stalls per dwelling unit represents an increase.

In this case, "multi-unit" refers to any residential building that has 2 or more dwelling units in a "stacked" arrangement (one above another).

PUBLIC INSPECTION – A copy of the proposed bylaw will be available for examination, on the City's website, commencing **Friday**, **July 7**, **2023**.

PUBLIC HEARING – City Council will hold a public hearing in relation to the proposed bylaw **July 12, 2023** at 1:00 p.m. Citizens who want to address **City Council** may attend the meeting via teleconference or in person.

To attend, you must register with the Office of the City Clerk by (no later than) **12:00 p.m. on Monday, July 10, 2023.** If attending by teleconference you must also provide the telephone number you will be using to call into the meeting with, when registering.
