## PUBLIC NOTICE ZONING BYLAW AMENDMENT

Regina City Council, **at their November 19, 2025 meeting, starting at 1:00 p.m.**, will facilitate a public hearing respecting proposed amendments to *The Regina Zoning Bylaw, 2019*, as described below.

### Zoning Bylaw Amendments

This involves making text changes to allow manufactured homes on residential lots.

**REASON:** The Zoning Bylaw serves as a regulatory guide for City administration and the public. Amendments to the Zoning Bylaw are required to keep up with current housing needs. These amendments to allow manufactured homes on all residential-zoned lots will align the Zoning Bylaw with the city's Strategic Priority of Livability through increasing housing option diversity throughout the city.

**INSPECTION:** A copy of the proposed amendment bylaw will be available for examination on the City's website commencing **November 14, 2025**.

Citizens who want to address City Council may attend the meeting in person or via teleconference.
