NOTICE OF INTENTION TO CONSIDER AMENDMENTS TO BORROWING AND **GUARANTEE BYLAW**

The City of Regina hereby gives notice, pursuant to sections 101 and 102 of The Cities Act and The Public Notice Policy Bylaw, Bylaw No. 2020-28, of its intention to consider amendments to The Regina Exhibition Association Limited Borrowing and Guarantee Bylaw, 2015, Bylaw 2015-25, to increase the maximum amount borrowed from \$13 million up to a maximum amount of \$21 million. The changes are necessary to provide flexibility in meeting the operating needs of Regina Exhibition Association Limited resulting from the COVID-19 pandemic.

The particulars of the report and amendments to Bylaw 2015-25 will be considered by Executive Committee on December 9, 2020 at 9 a.m. and then by City Council on December 16, 2020 at 1:30 p.m.
