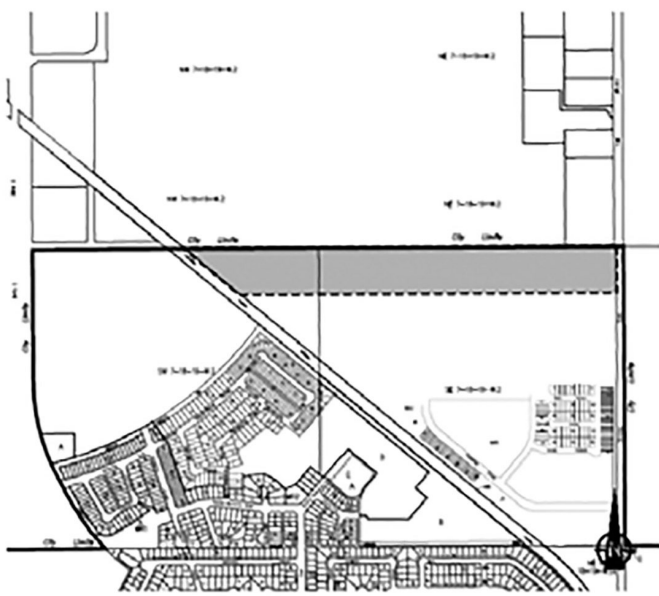

PROPOSED ZONING BYLAW AMENDMENT – BYLAW NO. 2022-54

Regina City Council intends to consider an amendment to *Regina Zoning Bylaw, 2019*. The properties identified and as shown on the map below will be considered for rezoning as follows:

Legal Description: being part of SW07-18-19-2 Ext 105 and SE07-18-19-2 Ext3
Civic Address: being Part of 1500 N Winnipeg Street
Current Zoning: UH-Urban Holding
Proposed Zoning: RW-Railway Zone
Zoning Bylaw Map No(s): 2694(A) and 2894(A)



REASON – The proposed amendments to the Zoning Bylaw include rezoning the Subject Property from the UH-Urban Holding Zone to RW-Railway Zone to facilitate the development of a rail spur line that will serve the proposed Viterra Canola Crush Facility in the RM of Sherwood.

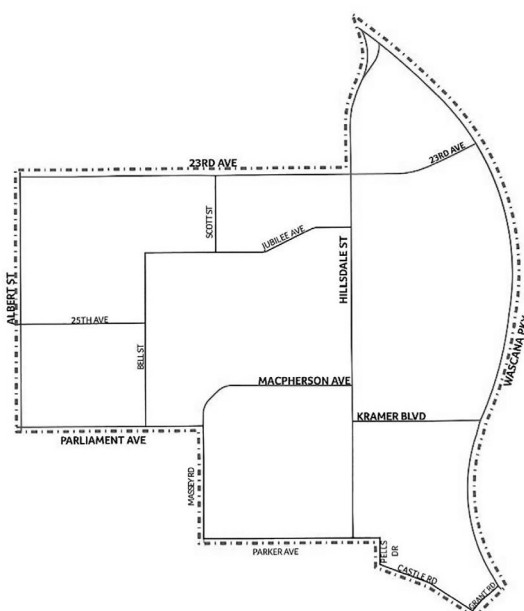
