

PROPOSED AMENDMENT - BYLAW NO. 2022-50

Regina City Council intends to consider an amendment to The Development Application Fee Bylaw, 2008 which will affect all land and development within the boundaries of the City Centre-area and Heritage and North Central neighbourhoods, as outlined on the map below:



REASON – The proposed amendment will effectively waive the imposition of Official Community Plan Amendment Application Fees, Zoning Bylaw Amendment Application Fees and Discretionary Use Application Fees within the City Centre-area and the Heritage and North Central neighbourhoods for applications supporting intensified development.

PUBLIC INSPECTION – An electronic copy of the proposed amending bylaw, and any relevant maps, may be inspected, upon request, commencing Monday, October 3, 2022.
