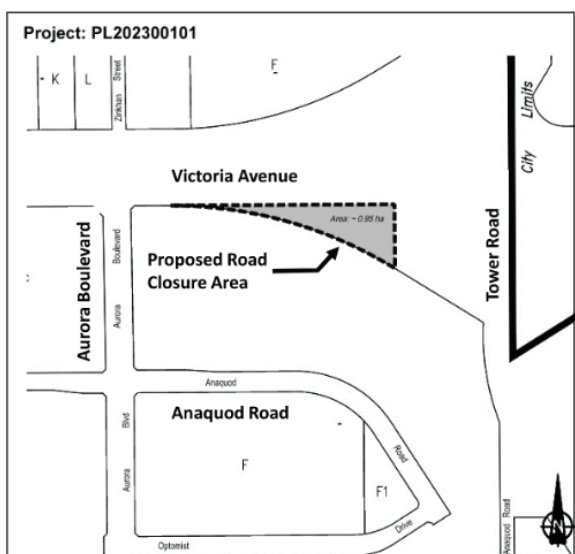


PUBLIC NOTICE:
