### CONCEPT PLAN AMENDMENT, ZONING BYLAW AMENDMENT AND DISCRETIONARY USE APPLICATION

Regina City Council intends to consider the following amendments to the Westerra Concept Plan, *Regina Zoning Bylaw, 2019*, and a Discretionary Use application:

1. Amend a portion of the Westerra Concept Plan from Main Street Retail to Medium Density Residential, rezone a portion of West Market Street to from MH – Mixed High Rise to RL – Residential Low Rise and allow for a planned group of dwellings located at 1501 West Market Street

**Reason:** The proposal located at 1501 West Market Street intends to accommodate medium density residential housing units on Parcels 1 and 3 along the east side of West Market Street.
