

CITY OF REGINA FINDING MIDDLE GROUND DESIGN COMPETITION

TERMS & CONDITIONS

General

1. City of Regina (the “City”) is hosting the City of Regina Finding Middle Ground Design Competition (the “Competition”). On the City of Regina’s website, at Regina.ca/FindingMiddleGround, entrants can review the Design Brief to learn more about the Competition and find instructions to participate in the Competition.
2. By making a submission to the City for the Competition, each entrant agrees to accept and abide by these terms and conditions (the “Competition Terms and Conditions”), all Competition parameters as set out in the Design Brief, and any and all decisions of the City and the City’s Competition Jury with respect to any aspect of this Competition, including without limitation the eligibility of entries.

Eligibility

3. Participation in the Competition is limited to corporations, individuals or groups as further described in the Design Brief. Individuals must be 18 years of age or older at the time of entry. City of Regina staff, steering committee members, jurors and their immediate family or corporations controlled or directed by them are not eligible. Participants must register by 5:00 p.m. CST on October 10, 2025 and must make their submission by 5:00 p.m. CST on November 7, 2025 (the “Deadlines”).
4. Submissions must be owned by the entrant and the entrant’s own work and may not include any material owned or controlled by third parties (unless the entrant can provide written documentation of permission to use any materials owned by a third party as set forth below or in a form and substance determined by the City in its sole discretion).

Prizes

5. The entrant agrees that the City, including its Jury, will have flexibility in determining the prizes awarded and honourable mentions to highlight the features that exemplify specific criteria. The City shall not be required to issue any or all prizes as described by the City in promotional materials or its Design Brief and may alter such prizes as it sees fit. For example, The City may declare two winners and split the winner and runner up prize money equally between the two or vary the number of winners. In the event of two winners the total prize money for the Competition will not be increased. The City, through its Jury, shall have unlimited authority and discretion as the final arbiter of the Competition.

Intellectual Property

6. The entrant will retain all intellectual property rights in the submission except as otherwise licensed to the City and the Canada Mortgage and Housing Corporation (CMHC) as set out herein. The entrant agrees that it has the authority to grant the rights herein. For good and valuable consideration, the receipt and legal sufficiency of which is hereby acknowledged, the entrant hereby irrevocably and unconditionally grants to the City and CMHC the right (but not the obligation) to use their submissions in whole or in part, to reproduce, distribute, display and create derivative works of the entrant’s submission in connection with the Competition for no additional compensation in any and all languages,

by any and all means, media, devices, processes and technology now known or hereafter devised, in perpetuity worldwide at no charge to the City. The City shall attribute the creation of the design to the entrant.

Release and Indemnity

7. The City provides no warranty in any information provided by the City. The City shall not be liable for errors and omissions in the information. The entrant hereby forever releases and discharges the City from any liability as a result of participation in the Competition or reliance on any information provided by the City, technical or otherwise in relation to the Competition. The City shall not be liable for any use made by third parties of the designs submitted to the Competition. The entrant agrees to indemnify and hold harmless the City against any and all claims made by third parties by reason of any act or omission of the entrant.

Carrying out the Competition

8. The decisions of the City are final and binding in all matters related to this Competition.
9. The City is not responsible for submissions that are incomplete or do not conform to or satisfy the conditions of these Competition Terms and Conditions and all such submissions may be discarded.
10. The City reserves the right, in its sole discretion, to terminate, modify or suspend the Competition, or modify the Competition terms and conditions at any time for any reason whatsoever.
11. The City will not be liable for any human or technical errors that may arise or occur in connection with the Competition. The City assumes no responsibility for any error, omission, interruption, deletion, defect, delay in operation or transmission, communications line failure, theft or destruction or unauthorized access to, or alteration of the entries.
12. The City reserves the right at its sole discretion to disregard any submission from an entrant who tampers with or attempts to tamper with the entry process.

Jurisdiction

13. This Competition is governed by the laws of Saskatchewan and the laws of Canada applicable therein, and is subject to all applicable federal, provincial and municipal laws and regulations. By entering this Competition, the entrant agrees that the courts of the Province of Saskatchewan, Canada shall have jurisdiction to entertain any action or other legal proceedings based on any provision of the Competition Terms and Conditions or the running of this Competition. The entrant hereby irrevocably attorns to the exclusive jurisdiction of the courts of the Province of Saskatchewan.
