

**City of Regina**  
**National Volunteer Week Giveaway 2025**  
**OFFICIAL RULES AND REGULATIONS**

**General**

1. City of Regina (the "Contest Sponsor", "City") is sponsoring the **National Volunteer Week Giveaway 2025** (the "Contest"). The Contest will open at 12:00 a.m. CST on April 27, 2025 (the "Opening Date") and close at 11:59 p.m. CST on May 3, 2025 (the "Closing Date").
2. By entering this Contest, the entrants automatically agree to accept and abide by these rules and regulations (the "Contest Rules"). All decisions of the Contest Sponsor with respect to any aspect of this Contest, including without limitation the eligibility of entries, are final and binding on all entrants in all matters as they relate to this Contest.

**Eligibility**

3. Participation is open only to City of Regina residents who have reached the age of majority in their jurisdiction of residence at the time of submission.
  - a. For participants under the age of 18, please have a parent or guardian enter on your behalf.
4. The City reserves the right to verify the validity and originality of any entrant (including an entrant's identity and address) and to disqualify any entrant who submits an entry that is not in accordance with these Contest Rules. Failure by the Contest Sponsor to enforce any of its rights at any stage does not constitute a waiver of those rights.

**How to Enter**

5. To enter the Contest, entrants must:
  - a. Visit the City of Regina's "Celebrate a Volunteer" Page at <https://www.regina.ca/parks-recreation-culture/community/associations-boards/celebrate-a-volunteer/>
  - b. Fill in the Celebrate a Volunteer form on the page.
  - c. Consent and agree to the terms.
  - d. "Submit" the form.
  - e. The contents of the submitted form are collectively referred to as the "Submission".
6. The Contest Sponsor is not responsible for entries that are incomplete or do not conform to or satisfy the condition of these Contest Rules and all such entries may be disqualified. All entries become the sole property of the Contest Sponsor and none will be returned.
7. No Purchase Necessary.
8. By entering the Contest, each entrant consents to the use of their name without

compensation in any publicity or advertising carried out in any medium worldwide by either or both of the Contest Sponsor and/or its advertising or promotional agencies without limitation or further notification or compensation.

## **Requirements**

9. By submitting a Submission each entrant agrees that:
  - a. By participating in the Contest through this website entrants expressly agree to be bound by, accept and comply with these Contest Rules and that any and all decisions of the Contest Sponsor with respect to any aspect of this Contest, including without limitation the eligibility of Submissions, are final and binding on all entrants in all matters as they relate to this Contest;

## **Prizes Available**

12. A total of thirty (30) prizes are available to be won (the "Prize").
13. Each Prize shall consist of the following:
  - a. One (1) City of Regina Family Leisure Pass (1 Day) (ARV CA\$14.41);
  - b. One (1) City of Regina "R" Lapel Pin (ARV CA\$2.50);
14. Prizes are not transferable and must be accepted as awarded with no substitutions, whether in cash or otherwise, except at the Contest Sponsor's sole discretion. The Contest Sponsor reserves the right to substitute a prize of equivalent or greater value if a prize cannot be awarded as described for any reason.
15. Odds of winning depend on the number of eligible entries received.

## **The Draw**

16. All eligible entries that are received by 11:59 p.m. CST on the Closing Date will be entered into a random draw.
17. A Draw will be held on the next following business day:
  - a. Monday, May 5, 2025.
18. The selected entrant(s) will be notified using provided contact details on the same business day their name is drawn ("Notification").
19. The selected entrant(s) must:
  - a. Respond to the Notification of selection within seven (7) days;
  - b. Correctly answer, unassisted, a time-limited mathematical skill-testing question;
  - c. Sign and return any required prize claim forms and releases within the timeframe specified below; and
  - d. Otherwise comply with these Contest Rules.
20. The selected entrant's name and submission may be posted on the City of Regina's official social media.
21. By entering the Contest, each selected entrant agrees to sign and return the following to the City of Regina within five (5) days of accepting the winner Notification:
  - a. A form affirming eligibility and compliance with all Contest Rules (form may require notarization);
  - b. A liability release form releasing the Contest Sponsor, their directors, employees, officers, agents and affiliates from all liability arising from or relating to the acceptance, receipt, possession, use or misuse of an awarded Prize, participation in any Contest-related activity including any travel related thereto and/or participation in this Contest; and
