## Easy and Flexible Payment Options for Fitness and Leisure Activities

Purchasing a Leisure Pass has never been easier. With the City of Regina's pre-authorized payment plan you can purchase a 6 or 12 month pass and spread your payments throughout the year.

### How Do Pre-Authorized Payments Work?

Select the pass you want to purchase (6 or 12 month). Complete the attached application form and attach a VOID cheque from the account you want your payments to be drawn from. Give your form to a cashier at the Fieldhouse, Lawson Aquatic Centre, Sandra Schmirler Leisure Centre or the North West Leisure Centre when you purchase your pass.

At the time of purchase, a payment equal to one month registration is required (see 1<sup>st</sup> payment column). On the 1<sup>st</sup> or 15<sup>th</sup> of each month, your selected account will be debited for the remainder in monthly installments.
