

Reason:

The purpose of the Zoning Bylaw Amendment is rezone a parcel of land in Harbour Landing from UH - Urban Holding Zone to DCD12 - Direct Control District Suburban Narrow-Lot Residential and R5 – Medium Density Residential Zone to accommodate low and medium density residential lots in the Harbour Landing Neighbourhood.

Note: The July 14 and July 21, 2018 advertisement of Bylaw No. 2018-39 provided an inaccurate legal description of the land to be rezoned as well as an inaccurate description of the proposed zoning, which has now been corrected. The intent of the advertisement remains unchanged. Council will be considering Bylaw No. 2018-39 at the July 30, 2018 City Council Meeting.
